**NOTES:**

1. This form of proxy must be dated and signed by the member or his attorney authorized in writing or, if the member is a body corporate, this form of proxy must be executed under its corporate seal or by an officer or attorney thereof duly authorized.

To exercise such right the member must insert the name of the proxy holder in the blank space provided for that purpose and must delete or strike out the name of John Petryshen, such deletion to be initialed by the person or officer signing the form of proxy.
